- b) At the meeting immediately before the matter is discussed

A member who has declared an interest must not:

Preside at the part of the meeting relating to the matter: or Participate in, or be present during any discussion or decision making procedure relating to the matter.

Unless the member is allowed to do so under Section 5.68 or 5.69, Local Government Act 1995

#### **SUMMARY:**

For the Committee to consider the result of Tender 01/13 – Supply of Housing.

#### **BACKGROUND:**

The decision to call Tenders for staff housing was resolved at the Ordinary Meeting of Council held Thursday 1 August 2013.

Specifications were prepared, a consultant was commissioned and tenders were advertised.

#### **COMMENT:**

Tender 01/13 – Supply of Housing was advertised in the West Australian newspaper on Saturday 3 August 2013 and closed at 4.00pm on Tuesday 20 August 2013.

Tenders were opened at 4.20pm on Tuesday 20 August 2013 in the Council Chambers in the presence of:

• Mr G Dwyer, Shire President

- Mr P Crawford, Chief Executive Officer
- Ms R Jones, Deputy Chief Executive Officer and in the following order:
- WBS Modular
- McGrath Homes
- Fleetwood
- T+R Homes

A fifth tender was received from AMS on Wednesday 21 August 20123 and as it did not arrive prior to tenders closing, will be disqualified.

A summary of tender prices received is as follows:

The Housing Committee travelled to Perth to view the proposed units on Friday 23 and Saturday 24 August 2013 and will present a verbal report on their findings to the Committee.

Report from consultant Mr Ian Mackay of Mackay Projects Pty Ltd on the four conforming tenders received, is as follows:

- 1. WBS Modular Group Company offer four (4) 3 x 2 houses of a single style.
- 2. McGrath Homes offer four (4) houses of a single style 'Irwin'
- 3. T+R Homes offer four (4) 3 x 2 houses in three (3) styles one of style 'Bushman', two of style 'Killara' and one of style 'Evolution'.
- 4. Fleetwood offer four (4) 3 x 2 homes of a single style 'The Flinders'.

Mr Mackay recommends that Housing Tender 01/13 be awarded to T+R Homes as outlined in the attachment.
