THE SHIRE PRESIDENT'S REPORT

August 2021



At the Northern Goldfields Working Group meeting in Kalgoorlie on 30 July 2021, Southern Parks and DFES addressed the Group. Mr Lyndsay Stockdale gave a talk on water options for the Northern Goldfields and Australia.

Councillors J Dwyer, Mader and the Chief Executive Officer (CEO) also attended the presentation following the GVROC meeting.

Along with most of Australia, I participated in the 2021 Census on the night of Tuesday 10 August, 2021 and we now await the release of the data for the Shire of Menzies.

The CEO and I met with Mr Marcus Falconer from Australia's Golden Outback during his visit to the Menzies Shire on 12 August 2021. We discussed general matters but in particular, tourism in the Menzies Shire.

A Briefing Session on 19 August 2021 was attended by all Councillors with video conferencing becoming a well-used, accepted and convenient practice.

The CEO and I met with Mr Wilson Tucker MLC, from the Daylight Savings Party, on 26 August 2021 in Kalgoorlie for discussions on a range of issues including housing, tourism and the mining industry.

Vaccinations for Covid-19 are taking place across the Goldfields and I urge those who are wishing to have the vaccine to do so (be that at Menzies, Leonora or Kalgoorlie)

CHIEF EXECUTIVE OFFICER'S REPORT

August 2021

The end of August sees the end of winter and the beginning of the wildflower season. With good winter rains we can expect a very good season and a continuation of the strong tourist numbers. It is pleasing to see so many caravans in town and out at our tourist attractions.

The Shire has commenced several projects over the past month which include:

Roadworks to the Tjuntjuntjara Access Road: Works to improve the access road commenced during August.

Fitting out of a new Menzies Café: Fit out of the Old Butcher Shop commenced in August and will be completed in September. We are hoping for our first burger at the end of September.

New Depot Buildings: The works crew have been getting the site ready for a new depot building which will go behind the Old Post Office.

Several other projects have been tendered and will commence within the next month or so. We are pushing along with our capital program and believe we can deliver most of it this financial year despite the labour and contractor shortage in the area.

Council elections will be held in October and nominations are open between the 02nd and 09th of September. Information is available on the Shire website and in this newsletter. Candidates are required to complete an induction package before they can nominate. Being a Councillor can be very rewarding and allows you to have input into how we spend Shire funds and the governance of the Shire.

We have had a few complaints of vehicle noise and disturbance in the Kookynie area over the past few weeks. Off road vehicles being driven on roads or in a dangerous manner is a police matter. We will assist where possible, but the Shire has limited powers in regard to vehicles.

Nominations must be lodged with the Returning Officer:

- at any time during the above period by arrangement; or
- between 2:00pm and 4:00 PM Thursday, 9 September 2021 (close of nominations) at the Shire of Menzies, Shenton Street, MENZIES.

Nominations Requirements

Candidates are required to lodge with the Returning Officer:

- a completed nomination in the prescribed form, signed and witnessed. This form is available from the Returning Officer or the Western Australian Electoral Commission(www.elections.wa.gov.au);
- a single A4 page profile of not more than 800 characters (including spaces) containing information about the candidate;
- a nomination deposit of \$80 (cash, bank cheque or postal order);
- (optional) a recent passport-sized photograph of the candidate's head, or head and shoulders; and
- every candidate must have completed the online course titled *Induction for prospective candidates*, available at www.dlgsc.wa.gov.au, prior to nominating.

The Commission has developed an online system called Nomination Builder to assist candidates to complete their nomination form which includes the candidate profile. This is the preferred method of completing the nomination form and profile for elections conducted by the Commission. Candidates complete their nomination details and profile, print the completed form which has a reference number allocated and lodge it with the Returning Officer. The nomination builder can be accessed via www.elections.wa.gov.au.

Where an agent lodges a nomination on a candidate's behalf, it must be in the prescribed form with a written authorisation signed by the candidate.

The documents may be hand delivered or posted to the Returning Officer and must be received by the close of nominations.

Information for parents – When is it OK to miss school?

It is important for children to attend school all day, every day. Going to school every day is vitally important so your child does not miss out on important ideas, concepts, knowledge and skills for future learning. At Menzies CS, we want your child to do their very best. To get the best education, they need to go to school every day.

By working together, our school community can support your child's attendance.

When is it OK to not go to school?

An OK reason is one that prevents your child from getting to school. This could include:

- your child is unable to attend because they are sick
- attending cultural or religious observances such as sorry time and funerals
- an unavoidable medical appointment
- an unavoidable natural event such as flood waters or a cyclone

The Principal decides if the reason given for your child's absence is acceptable.

It's NOT OK to miss school if your child:

- is celebrating a birthday
- is going on a family holiday
- is visiting family and friends
- has slept in or had a big weekend
- is looking after other children
- has sport or other recreational activities that have not been approved by the school
- has appointment such as haircuts and minor check ups
- doesn't feel like coming to school

If possible, routine medical and other health appointments should be made either before or after school, or during the school holidays.

Do you need to let the school know if your child will be away from school?

Yes, you need to let the school know the reason why your child is going to be, or has been, absent from school as soon as possible. Where possible, please discuss any upcoming

absences in advance so we can let you know of important learning or activities your child will miss out on.

This requires a responsible person, usually a parent, to provide a reason for the absence **within three school days**.

Having information about why your child is missing school helps us plan for their return to school and work out whether we can provide any further help to you.

Why is going to school so important?

- At school, many concepts such as literacy and numeracy are taught in a sequence. Missing school means missing out on learning – which can often make it difficult to catch up later. **This is particularly important in the early years when essential foundation skills are being taught.**
- Going to school every day helps children learn the important life skill of 'showing up' – at school, at work, to sport and other commitments.
- Research from the Western Australian Telethon Kids Institute shows that every day at school counts towards a student's learning. Students who attend regularly, generally do better at school and in life.

The requirements

- Section 23 of the *School Education Act 1999* requires for every year of the student's compulsory education period (Pre-primary onwards) that the student attend the school at which they are enrolled, or participate in an educational program of the school, on the days on which it is open for instruction.
- When a student's attendance falls below 90% or is identified as a concern, the [*Student Attendance in Public Schools*](#) policy and procedures requires the school to investigate the reasons for a student's absence, discuss with parents and implement strategies for improvement that are linked to the causes of absence

We are so proud to announce that we will be rolling out a new pilot program next month across Leonora and Laverton! This has been months in the making and we look forward to sharing more in our next edition!

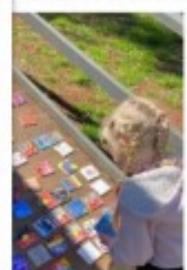

The COVID-19 vaccines are new, and it is very normal for people to have questions. There is so much information – and misinformation – it can be overwhelming. Together, we need to build vaccine confidence because each and every vaccinated person helps us move past the pandemic.

The vaccines are safe

Many people around the world worked together to create the COVID-19 vaccine, sharing money and scientists to get it done in just months, without missing any steps. Vaccines are only allowed in Australia after being tested and found to be safe and effective. All vaccines continue to be quality tested and monitored for safety.



The COVID-19 vaccines do not contain live virus and cannot give you COVID-19

The vaccines pretend to be the real virus and teach your body how to defend itself. This will help stop you from getting really sick and going to hospital or even dying.

Calling 000

Police, Fire or Ambulance

When you are transferred to the correct service you may be asked the following questions:
What is the address of the emergency? Street, cross reference or landmark will be required.

What is the telephone number you are calling from? This is in case your call is terminated or further information is required.

Tell me exactly what has happened? Provide a brief description of the problem.

How old is s/he? If unknown then approximate age.

Is s/he awake (conscious)? Yes or no answer required.

Is s/he breathing? Yes or no answer required.

The Communications Officer will then ask a series of further questions more specific to the problem identified. Answering these questions will ensure the most appropriate ambulance response is provided.

The Communications Officer will give you advice over the phone to assist the patient prior to the arrival of an ambulance. They may also ask you to turn on front lights if it is dark; if possible have someone wait out the front; and make sure the door is unlocked and open so the paramedics can enter.

Please remember to try and stay calm and speak slowly to the Communications Officer. Often an ambulance will be dispatched while you are still on the phone.

If in doubt you should always call triple zero (000). Sadly many people do not call for an ambulance as they are unsure of whether the situation is an emergency or they are concerned about the cost.

By calling triple zero (000), you may save someone's life.



Effective 1 November 2021, the Call A Doc After Hours Doctor service available to certain Western Australian regional communities, will be replaced by Healthdirect.

Why is the service ending?

WA Primary Health Alliance has funded Call A Doc for several years, as part of the Australian Government Department of Health's Primary Health Network (PHN) program. The Department of Health has now confirmed Healthdirect as its primary after-hours advice and treatment service. As such, WA Primary Health Alliance, as the operator of the Country WA PHN will no longer fund Call A Doc. Call A Doc has been used as a stop gap to provide in hours services in areas with ongoing GP workforce shortages, however, this is not a sustainable model. The provision of regional workforce is the responsibility of agencies including WA Country Health Service and Rural Health West.

What services will the community have access to?

For those who might struggle to access face-to-face health services, particularly in the afterhours period and in rural and remote regions, Healthdirect's services are essential healthcare alternatives. Services include online health information, a symptom checker, a 24/7 helpline operated by registered nurses, and, after hours, the nurses may offer a call back or a video call from a GP who can provide advice.

How will Healthdirect localise their advice?

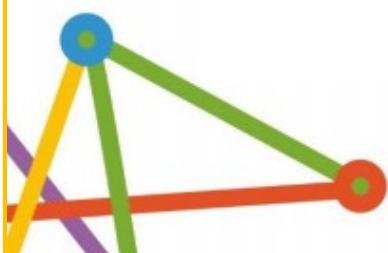
Healthdirect can localise advice based on their knowledge of local services.

What will people do if there is no GP within reasonable travelling distance?

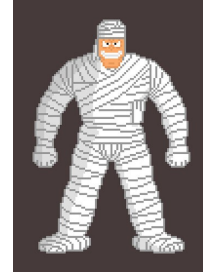
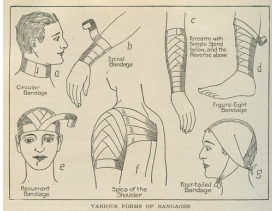
If someone needs assistance and it is not an emergency, they should contact Healthdirect. Pharmacies can provide limited health advice including dispensing non-prescription medications and limited prescription medications, as well as medical certificates. In an emergency, people should always call 000 or go direct to their nearest emergency department.

Why can't telehealth be used by these communities?

Telehealth MBS item numbers often require patients to have had a face-to-face consultation within the last 12 months with the healthcare provider in question. There are some exceptions including when the area is impacted by COVID-19, at which time telehealth may be a temporary solution.

The Shire of Menzies proposes to adopt the following local laws –

1. Shire of Menzies Bush Fire Brigades Amendment Local Law 2021;

- Purpose – to amend the Bush Fire Brigades Local Law so as to permit greater flexibility
- Effect – amendment by removing mandatory training and specified dates to be met by bush fires brigades

2. Shire of Menzies Cemeteries Local Law 2021;

- Purpose – to provide for the management of cemeteries within the district and create offences for non-compliance
- Effect – to provide for the management and control of cemeteries

3. Shire of Menzies Dogs Local Law 2021

- Purpose – to make provisions about the impounding, the number that may be kept on premises, the manner of keeping dogs and create offences for non-compliance
- Effect – to repeal existing Dogs Local Law 2007 and provide for the controls of dogs within the district and impose penalties for non-compliance

4. Shire of Menzies Meeting Procedures Local Law 2021

- Purpose – for management of meetings of the local government
- Effect – to provide for the conduct of Council, committee and electors meetings

5. Shire of Menzies Repeal Local Law 2021

- Purpose – to revoke old local laws no longer having relevance
- Effect – revocation of outdated requirements and local laws

Local Government (Elections) Amendment Regulations 2021

The Local Government (Elections) Amendment Regulations 2021 come into effect on 2 August 2021.

These regulations deal with an update to the mandatory induction course for prospective candidates, requirements for candidate nomination forms in relation to the mandatory induction course and changes to the calculation of the length of candidate profiles.

Important information regarding these updates is on the DLGSC website.

Please note, individuals who completed the mandatory induction course before 31 May 2021 will be required to complete the updated course to be eligible to nominate as a candidate.

Individuals who completed the updated mandatory induction course from 31 May to 1 August 2021 are not required to do the course again; but will be required to include the reference number and date of completion on their nomination form.

The 'Be a Vocal Local' message has been developed to encourage more people from diverse backgrounds to stand for council.

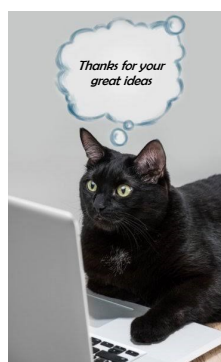

SEVEN GOLDEN RULES FOR PROSPECTING

1.

Put safety first

- Make sure you have enough water, fuel, maps and first aid supplies.
- Give serious consideration to taking some form of telecommunications and a global positioning system to fix locations, and a Personal Locator Beacon (PLB) – it may turn out to be your most important safety device.

2.

Obtain a Miner's Right permit

when prospecting on vacant Crown land (\$25 from any Mining Registrar's office).

3.

Obtain a 40E permit

prior to prospecting within an exploration tenement (if you don't have written permission from the tenement holder).

4.

Get written permission

from the tenement holder when prospecting on:

- a mining lease
- an exploration licence (if you don't have a 40E permit)
- a prospecting licence

5.

Comply with all legal requirements

when prospecting on a pastoral lease. You cannot prospect within 100 metres of any occupied building or within 400 metres of any livestock watering point without the consent of the pastoralist.

6.

Show respect when on Crown land

because it is used by other people or set aside for many purposes.

7.

Fill any holes

that you dug and repair ground that has been disturbed.

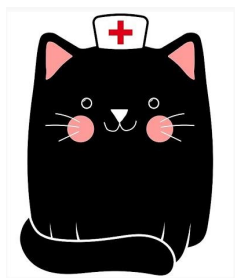
