### THE SHIRE PRESIDENT'S REPORT



### **DECEMBER 2022**

Prior to the Regional Road Group Meeting on Friday 25th November ACEO, Bruce Lorimer (Engineering Consultant) and myself met with Shane Powell, Main Roads, for a discussion on water and gravel availability in relation to the Cut Line Project.

On 29th November ACEO and I attended, via bus from Coolgardie, a site visit at Intractable Waste Facility 90km north of the Great Eastern Highway. We viewed the completed, fenced and rehabilitated waste site and an inspection of the camp facilities. Following the site visit we attended a meeting of the Community Liaison Committee.

The annual Community Christmas Party was held at the Youth Centre on 15th December. Approx. 90 people attended a very enjoyable evening.

ACEO, Cr Dwyer J, Mr Rob Stewart (Acting CEO elect) and myself attended a meeting of the Golden Quest Discovery Trail held in Leonora on 16th December. Discussions centred around the Membership of Shire of Coolgardie and City of Kalgoorlie Boulder as to whether they are going to join the association. In regard to the trail itself, it is now noticeable that the intent of showing to the public the old townsites and surrounds is now changing due to the development of mining activities, in particular the utilisation of bypass roads around these townsites that were built originally close to the mine sites.

Following the GQDTA Meeting, Northern Goldfields Working Group held their meeting at 1.00pm. The group in attendance had discussions on all ongoing issues from the action sheet.

### SHIRE NOTES

#### 1. Workforce Accommodation

Council has received a preliminary application regarding the establishment of workforce accommodation in Webb Street, Menzies.

The proposal is for 12 transportable accommodation buildings, each of the 12 buildings would contain 4 accommodation rooms, making for a 48 person work camp.

Under the Shire of Menzies Town Planning Scheme the proposal must be advertised for public comment prior to Council making a decision on the application.

At the Council Meeting held on 20 December 2022 Council resolved as follows:

"That the applicant be advised that "Workforce Accommodation" is a land use that must be advertised upon 56-58 (Lots 1100 & 403) Webb Street, Menzies prior to determination.

That the Acting CEO arrange advertising of the proposal following receipt of a formal application."

#### 2. Communication Mast

Council has previously granted approval for the siting of a communication mast on Lot 100 Suiter Street, Menzies for the provision of internet service to the Mt Ida mine site.

Following a further application Council has supported a second site, that being 50 (Lot 1095) Archibald Street, Menzies. This site contains the St John Ambulance Sub Centre and is Crown Reserve 41269 with a management order issued to St John Ambulance WA.

In supporting a second site Council resolved as follows:

"That Council supports the siting of a communications mast at 50 (Lot 1095) Archibald Street, Menzies.

That the Acting CEO be delegated authority to approve the necessary planning and building approvals subject to the following conditions:

- a The applicant must obtain all necessary consent/tenure agreement of the landowner relevant to the site and the access to the site.
- b The applicant must submit all necessary information to enable the assessment of the planning and building permit applications.
- c That the structure comply with civil aviation requirements in respect to the Menzies airstrip.

#### Advice Notes:

(i) In regards to condition 1 the Western Australian Planning Commission have prepared State Planning Policy 5.2 'Telecommunications Infrastructure' and Section 6.3.1 outlines the information to be submitted when lodging a development application.

- Separate approvals to undertake certain activities may be required from other government agencies under separate legislation of which it is the applicant's responsibility to investigate and address.
- (iii) All operations must be carried out in accordance with any separate requirements from other government agencies under separate legislation which may include the Australian Communications and Media Authority, and Australian Radiation Protection and Nuclear Safety Agency pertaining (but not limited) to electromagnetic energy.
- (iv) In the event that the Shire CEO is not satisfied with the level of information provided by the applicant this matter is to be returned to a meeting of Council for further consideration."

### 3. Appointment of Chief Financial Officer

Congratulations to Kristy Van Kuyl on her appointment to the position of Chief Financial Officer with the Shire of Menzies. Kristy has filled the role in on acting capacity for the past five months following the resignation of Antonio Giometti.

#### 4. Road Construction

Work is continuing on the Menzies Evanston Road for the sealing of a further 5km section. Roadtech Civil & Construction (Roadtech) was awarded the contract for this work together with the resealing of a 10km section on the Menzies North West Road and the construction and sealing of the final 6kms of the Menzies North West Road to Lake Ballard.

In addition to the above, reconstruction and sealing works will be undertaken on the Kookynie-Malcolm Road between SLK 0.00 and SLK 3.74.

#### 5. Appointment of Acting CEO

My tenure as Acting CEO concludes on Friday 13 January, 2023. I would like to thank Council for giving me the opportunity to once again serve the Shire of Menzies. I would also like to acknowledge and thank the wonderful staff of the Shire that have assisted me over the past six months.

Mr Robert Stewart will fill the role, commencing 16 January 2023. Rob is an experienced CEO having served as CEO in a number of Metropolitan and Regional local governments.

### Budgie smugglers help deliver men's mental health message at Lake Ballard

A Perth-based health promotion charity visited the Goldfields last week to help foster positive mental health among regional residents and launch an unusual line of swimwear.

Men's Talk delivered its newly developed Blue Mind Roadshow in Menzies to provide information and techniques for residents to nurture their mental health.

During their three-day visit to the Goldfields, the Men's Talk team also held a promotional photoshoot at Lake Ballard to launch their "budgies for a cause" mental health promotional swimwear.

Men's Talk chief executive Paul Litwin told the Kalgoorlie Miner the budgie smugglers were designed by South Australian Aboriginal artist Bianka Carson and depicted a yarning circle demonstrating "how Aboriginal men have come together for thousands of years to talk and communicate".

All funds raised from sale of the swimwear will be donated to national Aboriginal men's crisis hotline Brother to Brother.

"Brother to Brother is a wonderful organisation which is set up specifically for Aboriginal men to speak to other Aboriginal men when they are in crisis," Mr Litwin said.

"We took these beautiful photos; it was an amazing location."

Mr Litwin said the Blue Mind Roadshow was developed to "put boots on the ground" in regional WA to promote awareness, information and education around mental health wellbeing.

"It isn't just a talk show, it's actually providing the important information and the skills for communities in the regions to be able to understand what mental wellbeing is and how to actually practice good mental wellbeing on a daily basis," he said.

"We're going around to these centres and providing them with mind exercises and mind knowledge to be able to cope ... and build resilience in (their) daily lives.

"Mental health in the regions is a significant issue. It's important to address that and to empower those communities with the tools to understand what they need to operate at an optimum level with their mental health and their physical health."

Mr Litwin said the first Blue Mind Roadshow was delivered in Esperance in October and was well received.

He said the Men's Talk team was invited by the Shire of Menzies to bring the concept to the Goldfields to assist their staff and community members.

The Blue Mind Roadshows were funded by the WA Primary Health Alliance through the Australian Suicide Prevention Network.

Mr Litwin said a mind and body balance workshop was held at Lake Ballard with physiotherapist and movement and breath specialist Cam Watkins to promote how "mental wellbeing and physical wellbeing are interconnected".

He said the organisation facilitated mental health first aid courses in metropolitan and regional WA with Beyond All Bounds founder Ben Broadbridge.

The charity's Blue Mind Project also delivers an Armed For Life Youth Resilience program with Adam Przytula.

Mr Litwin said Men's Talk's programs aimed to spark discussions about men's mental health and break down negative stigmas surrounding the topic.

He said the charity organisation was established in February last year in response to the high suicide rate among the Australian male population and operated off their "promotion, prevention and early intervention" philosophy.

"A lot of men will wait until the very last minute to either go and see a doctor or psychologist ... because of the typical stereotype 'I'll man up, I'll toughen up, I'll be fine'," he said.

"What we need to be doing, particularly for men in the community and men living in the regions, is to build capacity to actually understand what your own wellness is and what you should be doing with that wellness right at the very beginning before it becomes quite something quite serious."

Mr Litwin said while they primarily focused on men's mental health, the charity was able to help anyone in the community through their programs.

The organisation hoped to deliver the Blue Mind Roadshow in Kalgoorlie-Boulder and Geraldton next year.

Mr Litwin said the organisation was planning on developing "blue mind hubs" across regional WA, with the first centre scheduled to open in Esperance in about October.

"The concept of the blue mind hub is to have men's counselling, mentoring, resources all for men and it would be run by the communities themselves but we would help resource it," he said.

"Everything from financial counselling, parenting, relationships, wellbeing ... so that men in the community would be able to access that information through these blue mind hubs.

"We want to build blue mind hubs in the major regional centres around from Esperance all the way to Kununurra."

### Prevent mosquito bites





#### **COVER UP**

Wear long, loose-fitting, light coloured clothing, covering as much of the body as you can. Mosquitoes can bit through tight clothes like jeans. Make sure children are also covered up.



#### REPEL

Use insect repellent containing DEET (diethyltouluamide) or picaridin and always follow instructions on the label.



#### **CLEAN UP**

Stop mosquitoes breeding in water pooling around vour home or holiday accommodation by emptying water from











### SEVEN GOLDEN RULES FOR **PROSPECTING**

**Put safety first** 

Make sure you have enough water, fuel, maps and first aid supplies.

Give serious consideration to taking some form of telecommunications and a global positioning system to fix locations, and a Personal Locator Beacon (PLB)

— it may turn out to be your most important safety device.

Obtain a Miner's Right permit when prospecting on vacant Crown land (\$25 from any Mining Registrar's office).

Obtain a 40E permit prior to prospecting within an exploration tenement (if you don't have written permission from the tenement holder).

Get written permission from the tenement holder when prospecting on:

a mining lease an exploration licence (if you don't have a 40E permit) a prospecting licence

Comply with all legal requirements when prospecting on a pastoral lease. You cannot prospect within 100 metres of any occupied building or within 400 metres of any livestock watering point without the consent of the pastoralist.

Show respect when on Crown land because it is used by other people or set aside for many purposes.

Fill any holes that you dug and repair ground that has been disturbed.

### 1080 BAITING IN THIS AREA IS A RISK TO DOMESTIC PETS

Please be advised that baiting programs using 1080 poison are carried out across Western Australia, including this area, and are aimed at controlling wild dogs, feral cats, feral pigs, foxes and rabbits. The poison baits remain toxic for many months. You need to exercise caution. Domestic pets should be kept close and under control at all times. Owners may consider the use of leads and muzzles for their domestic pets.

1080 baiting is part of an integrated pest management program protecting livestock from death and injury; reducing the impact on pastoral and agricultural production; and helping to preserve the unique flora and fauna of WA. Baits are not intentionally laid in public areas such as road reserves, parking bays, rest stops or roadhouses however can be inadvertently moved into these areas by animals and birds.



On the home page of your Online Services account, select the Payments and Claims menu option.







### With Senior Regional Officer for Goldfields Esperance Bouyden McKenzie Post-Christmas gift returns and gift card rules

With the season of giving now over, many consumers will be considering returning their unwanted Christmas gifts or putting their new gift card in a drawer to spend later.

Under the Australian Consumer Law (ACL), consumers have certain rights when it comes to gifts that are faulty, unsafe, not as described or were not delivered in time.

If a gift is faulty, unsafe or not as described, Australian retailers must offer a remedy such as a refund, replacement or repair, even if it was on sale.

Generally though, proof of purchase is required, such as a receipt or credit card statement from the gift giver. Some retailers may offer a refund or credit without proof of purchase as a gesture of goodwill, but this not a requirement by law.

If you plan to return unwanted gifts such as a toy your child may already have or a shirt that doesn't fit properly, this is considered to be a "change of mind", which falls outside of the ACL. In this situation, retailers are under no obligation to offer a refund, store credit or exchange, so it is best to check their return policy.

If returning a gift, the original packaging should be included where possible unless the gift was faulty or breaks after use.

If you received a gift card for Christmas, make sure to check the expiry date. By law, a minimum expiry period of three years is required on most gift cards. Three years is a long time though, so consider using it before you put it in a drawer and forget about it. You also can't be certain the retailer will still be around in three years' time.

Finally, if a gift failed to turn up in time for Christmas, you may be entitled to a remedy but it is best to contact the retailer to resolve the issue first before lodging a complaint with Consumer Protection.

If post-Christmas consumer issues can't be resolved with the retailer, you can lodge a formal complaint on the <a href="mailto:Consumer Protection website">Consumer Protection website</a>.
