SUMMARY:	

To seek approval from Council to ask permission from the Electoral Commission to hold over vacant Council positions to be incorporated into the biennial election in October and to request that the Electoral Commission conduct these elections.

BACKGROUND:

The issue of Returning Officer was discussed at the April 28th 2011 meeting whereby Council requested the Deputy CEO to conduct the biennial election and the Deputy declined the request citing section 4.20 (2) of the Local Government Act 1995, in that written approval from the officer and the Electoral Commission was not held. Council subsequently decided to request the Electoral Commission to preside.

COMMENT:

With the recent demise of Cr. Lansdown and the subsequent resignation of Cr's Kelly and Pusey, three vacancies exist. It is reasonable to combine this election with the Biennial Election in October.
