Councillors should declare an interest:

- a) In a written notice given to the Chief Executive Officer (CEO) before the meeting: or
- b) At the meeting, immediately before the matter is discussed.

A member who has declared an interest must not:

- Preside at the part of the meeting relating to the matter: or
- Participate in or be present during the discussion of decision-making procedure relating to the matter unless the member is allowed to do so under Section 5.68 or 5.69 of the *Local Government Act 1995*.

SUMMARY:

RFT 02/21 was issued for upgrades and repairs to the Tjuntjuntjara Access Road from Shed Tank to SLK40 on the Tjuntjuntjara Access Road. This paper nominates a preferred tenderer for Council approval.

BACKGROUND:

Council budgets for FY 2020/21 included allocations for projects R2R049 and RC049 which were for upgrades and repairs to the Tjuntjuntjara Access Road. At the 29 April 2021 OCM Council resolved to incorporate R2R funding towards this project giving a total budget of \$627,002.

Tenders were advertised on 10 April 2021 and closed on 30 April 2021 at 1400.

The tender box was opened by CEO Brian Joiner in the presence of EO Sharlene Mik with one (1) member of the public present. One tender was received from Fraser Range Station.

COMMENT:

The tender was assessed by an external consultant, Greenfield Technical Services. As there was only one tender the external consultant was utilised to ensure the price was in line with expectations and that the company had the capability to deliver on the work.

The evaluation report and assessment summary form a confidential attachment to this report.

Greenfield's evaluation determined that Fraser Range Station was suitable for award of the tender.

If any of the provisional items described within the tender are required, the value of the contract may need to be varied.

It is recommended that the Council delegate responsibility to the Shire's Chief Executive Officer to negotiate any provisional items included in the RFT Pricing Schedule to a value of 10% of the total contract value as required.
