THE SHIRE PRESIDENT'S REPORT August 2021

On the morning of July 8th with Human Resource Consultant Anne Lake, Councillors attended a workshop for the final CEO Probation Review. Following at 1.30pm we attended a Special Council Meeting to endorse the



findings of the CEO's successful review and to adopt the 2021/2022 Annual Budget. To be noted Council did not increase the rates for 2021/2022 or 2020/2021.

14th July the CEO and I met with Greg Durack, CEO and Managing Director of Juno Minerals Ltd for discussions on the shipment of Iron Ore from Mt Ida and the various options available to Juno. A presentation will be delivered to Council at the Ordinary Meeting of Council on 29th July 2021.

Councillor J Dwyer and I on the evening of 21st July went along to the Kalgoorlie Boulder Chamber of Commerce and Industry "Business After Hours" to hear our CEO speak on the possibility of a future business incubator and the Shires plans following the approval of the 2021/2022 Budget.

Travelling back from Kalgoorlie the next day, Thursday 22nd July, I with fellow Councillors attended the July Briefing Session.

On Monday, 26th July the CEO and I took part in a video conference with WA Midwest Yilgarn Infrastructure Group Inc. general meeting. It was pleasing to see that some momentum is taking place with the group particularly with those Miners situated in the Menzies Shire. A face-to-face general meeting is planned for the week of the WALGA Conference at which the NGWG could attend.

CHIEF EXECUTIVE OFFICER'S REPORT

August 2021

Winter has definitely hit the region in the past month. Although some of the days have been glorious, we have had a lot of rain and some very cold nights. The cooler months have seen a large increase in the number of tourists visiting the region and I expect that to continue with the wildflower season shortly upon us. The benefit of strong winter rains could mean a lot of wildflowers in the region.

Early in the month Council approved our budget for the 2021/2022 financial year. The best news from this budget was Council deciding not to raise rates or fees and charges for this financial year. A rise is anticipated for next year, but Council wanted to have a zero rise this year to compensate for the hardship many have felt through COVID.

This year's budget included significant capital for a range of projects. This includes sealing of 10km of Menzies NW Road, 5km of Evanston Road, and building a road behind Marmion Village. These works are expected to commence in October this year. Other works include maintenance on the Lady Shenton Building, restoration of the Old Post Office, maintenance on Niagara Dam, construction of new accommodation on the Mercer Street Caravan Park site, allocation to a men's shed/arts centre, and numerous smaller projects. Most of the projects are well underway with planning, design, and documentation.

Council elections will be held this year with two seats available in the Rural Ward and three seats in the Town Ward. Nominations will be open between 02nd September and 09th September. Anyone wishing to nominate must complete an induction course before being able to nominate. The course is available on the Department of Local Government, Sports and Cultural Industries website at www.dlgsc.wa.gov.au/local-government/local-governments/council-elections/induction-for-prospective-candidates.

On a last note, we endeavour to keep the towns tidy and maintain facilities to a high standard. We welcome any feedback or any notifications of things that need attention.

IMPORTANT CHANGES TO CDP OBLIFGATIONS

As part of the 2021-22 Budget, the Government has announced a new remote jobs program commencing in 2023, which will replace the Community Development Program (CDP). The new program will be developed in partnership with Indigenous communities and will complement the broader New Employment Service Model being rolled out in the latter half of 2022. While the process is underway, the Government has made changes to Mutual Obligation Requirements for all CDP job seekers.

From May 2021, job seekers will be able to participate in activities on a voluntary basis, but will continue to have some compulsory requirements, such as attending appointments with service providers or looking for work.

Local Government (Elections) Amendment Regulations 2021

The Local Government (Elections) Amendment Regulations 2021 come into effect on 2 August 2021.

These regulations deal with an update to the mandatory induction course for prospective candidates, requirements for candidate nomination forms in relation to the mandatory induction course and changes to the calculation of the length of candidate profiles.

Important information regarding these updates is on the DLGSC website.

Please note, individuals who completed the mandatory induction course before 31 May 2021 will be required to complete the updated course to be eligible to nominate as a candidate

Individuals who completed the updated mandatory induction course from 31 May to 1 August 2021 are not required to do the course again; but will be required to include the reference number and date of completion on their nomination form

Local government elections coming up

There is just a month to go until nominations for this year's local government elections open.

DLGSC, in partnership with WALGA, Western Australian Electoral Commission and Local Government Professionals WA, has developed social media tiles and posters for distribution by local governments.

The 'Be a Vocal Local' message has been developed to encourage more people from diverse backgrounds to stand for council.

Nominations open 2 September and close 9 September, for the 16 October 2021 election.



Dear CRC Operator

I am writing to advise you about the \$500 WA Small Business and Charities Electricity Credit.

WA businesses and charities may be eligible to receive a \$500 credit to put towards their electricity costs. The credit is a WA Government initiative to offset the impacts of a mandatory 5-day lockdown in February 2021.

Small businesses and charities on an eligible tariff as at 2 February 2021 already received a \$500 credit to their Synergy or Horizon Power account. Businesses and charities who are billed by third parties and meet the scheme criteria are able to apply to RevenueWA for an equivalent payment. This includes businesses and charities with premises on an embedded network, sub-meter, supplied by an alternate energy supplier or otherwise billed by a third party.

Applications are now open and will close 30 September 2021.

Applicants should visit www.WA.gov.au/energycredit for full eligibility criteria and information about how to apply for the credit. They can also contact the business electricity credit team directly on (08) 9262 1165 or by email at sbcec@finance.wa.gov.au.







SEVEN GOLDEN RULES FOR **PROSPECTING**

- Put safety first

 Make sure you have enough water, fuel, maps and first aid supplies.

 Give serious consideration to taking some form of telecommunications and a global positioning system to fix locations, and a Personal Locator Beacon (PLB)

 it may turn out to be your most important safety device.

Obtain a Miner's Right permit

when prospecting on vacant Crown land (\$25 from any Mining Registrar's office).

Obtain a 40E permit

prior to prospecting within an exploration tenement (if you don't have written permission from the tenement holder).

Get written permission from the tenement holder when prospecting on:

- n the tenement holder when prospecting on: a mining lease an exploration licence (if you don't have a 40E permit)

Comply with all legal requirements

when prospecting on a pasteral lease. You cannot prospect within 100 metres of any occupied building or within 400 metres of any livestock watering point without the consent of the pastoralist.



Show respect when on Crown land because it is used by other people or set aside for many purposes.

Fill any holes that you dug and repair ground that has been disturbed.

1080 BAITING IN THIS AREA IS A RISK TO DOMESTIC PETS

Please be advised that baiting programs using 1080 poison are carried out across Western Australia, including this area, and are aimed at controlling wild dogs, feral cats, feral pigs, foxes and rabbits. The poison baits remain toxic for many months. You need to exercise caution. Domestic pets should be kept close and under control at all times. Owners may consider the use of leads and muzzles for their domestic pets.
